- 2 to 3 Working Days : Trade Name Approval
- 1 to 2 Working Days : Code Signing
- 2 to 3 Working Days : License Issuance
- Immigration & Visa Process Time
  - 4 to 5 Working Days : Immigration Card
  - 10 to 15 Working Days : Visa Process

# FREE ZONE COMPANIES(Process, Time & Cost)

#### Documents Required

Same as Required in Mainland Company Formation

#### Important Facts

Please note – Without Visa, you will never be able to get Emirates id in Dubai & will never be able to open account as well in Bank.

License Renewal Charges are to be paid every year in Freezones as well as in Mainland. Renewal Cost every year are ideally 50% to 70% of the Initial Company Formation Cost

Immigration card is Like registering your Firm Name in Immigration Department

Emirates ID Card is like an Aadhar Card in India, wherein Biometrics are captured while application.

#### Process & Timeline

3 to 7 Working Days for License Issuance
2 to 3 Working Days for Immigration Card
3 to 5 Working Days for E-VISA
-- After this you enter Dubai with E-VISA—
1 to 2 Working Days for Medical Test
3 to 5 Working Days for Physical / Sticker VISA
(If urgent required, then 1 Day Visa issuance service)
In the above mentioned 3 to 5 Working Days –
Emirates ID Online Booking appointment can be taken.

Emirates ID appointment depends on availability of time slots & you may even get time slots of after 5 to 7 days depending on the rush and location on centers.

# VISA TYPES

**(A)** INVESTOR VISA / PARTNER VISA – for Entrepreneurs

**(B)** EMPLOYMENT VISA – For Employees Hired under You

Relevant Qualification (HR Manager – HR Degree, A/cs Manager – Commerce Degree)

**(C)** DEPENDENT VISA (for Bringing your Family members here)

### **MAJOR CONDITION**

- Presence of 1 day in every 180 Days to continue VISA

- Validity of Visa is of 2 years. After every 2 years, Renewal – Cost 3000 to 4500 AED

If Condition not fulfilled, then VISA needs to be cancelled and reapplied by paying again same cost & You may face issue in License Renewal & Bank Account operations.

3. I wish to buy 1 or 2 Year Old Existing Company in UAE.

4. I wish to open the Bank account without taking the VISA.

5. I have got the offer from Freezone directly and they will not charge me any other fees. Have you considered other things like distance from Dubai, whether you have better option for your activities? What if your activity needs approval? Who will bring that approval? Who will guide you for all other processes after your license issuance. If you think, Freezone will support.. You are on a wrong track my dear friend.





### ATTESTATION PROCESS IN CASE OF SINGAPORE HOLDING COMPANY - BY T&T

 Board Resolution, Constitution (MOA) Document & Education Degree – These 3 document Attestation work to start as Attested Board resolution & MOA will be mandatorily required to be submitted in next 60 days once license is issued. And Attested Degree of Directors and Managers will be required when we apply for their VISA. (Attestation from UAE Embassy in Parent Company's Home Country as well as Attestation from MOFA in U.A.E). Initially Only Signed Board resolution and MOA Certified by ACRA will be sufficient for applying for license.

• Certificate of Incorporation & Business Profile (No need of Getting these documents attested while incorporating the Company in Dubai, if these two documents can be verified online). However during bank account opening, will need the attestation as and when bankers ask.
