# Minutes of the Managing Committee Meeting held on Saturday, 1st November 2017 at 5.00 pm at the Pune branch, ICAI Bhavan, Bibvewadi, Pune

- 1. Following members were present for the meeting:

- 2. The meeting was commenced with Mr. Arun Anandagiri, Chairman informing the committee about various programs and events concluded by the branch during the intervening period from the previous managing committee meeting.
- The minutes of the earlier managing committee meeting held were approved.
- 4. Upcoming programs to be held in the ensuing months were discussed at length. The Chairman elaborated his ideas and updated the members about the programs to be held in the next months. Major programs that were decided to be conducted were as follows:
- GST summit : Indirect Taxes committee
- A two days program on Transfer Pricing: Arun Anadagiri and Rekha Dhamnakar to coordinate
- The update about 18<sup>th</sup> and 19<sup>th</sup> November 2017 program Maharashtra Cooperative convention was given by Ruta Chitale. She expressed her anxiety on low number of registrations. It was decided to call other branches for jointly organising this program and help in registration.
- An event with Loksatta about GST was sought to be coordinated by Arun Anandagiri
- Looking at the demand of members for updates on Ind-AS, a dedicated week was decided to be conducted. Ruta Chitale and Arun Anadagiri were to coordinate for the same.
- Other programs that were to be conducted were: National conference on International Tax, Insolvency awareness session, Program on Capital markets, Program on Corporate Governance and Insolvency workshop.
- 5. Following matters were discussed with the permission of the Chair:
- a. Domestic RRC was decided to be carried out 28.11.2017 to 1.12.2017 at Udaipur and Ahmedabad. The itinerary was discussed and the members thought it would be better to arrange a Volvo from Ahmedabad to Udaipur. The sessions to be conducted were also discussed and the Chairman assured the committee that he will get the best of speakers to speak at RRC. It was also decided to visit and interact with Ahmedabad branch of WIRC of ICAL.
