

Declaration of result for Final, Foundation & CPT Examination held in the month of May/June 2018

The results of the Final Examination, Foundation Examination and Common Proficiency Test (CPT) held in May/June, 2018 are expected to be declared on **Friday, the 20th July 2018 around 6.00 P.M.**

The results of the Chartered Accountants Final Examination, Foundation Examination and Common Proficiency Test (CPT) held in May/June, 2018 will also be available on the following mentioned websites:-

In this connection, it is stated that branches having their websites may make necessary and timely arrangement for getting their website linked with the abovementioned website on **20th July, 2018** so that result is also available on the website of such branches. Arrangements have also been made for the students desirous of having results on their e-mail addresses to pre-register their requests at the website icaiaexam.icaai.org from **16th July, 2018** for Final Examination, Foundation Examination and Common Proficiency Test (CPT) held in May/June, 2018. All those registering their requests will be provided their results through e-mail to the e-mail addresses registered with us immediately after the declaration of the result.

Also It may be noted that the practice of hosting center wise result on the above mentioned websites and also sending region wise result on email to Branches and DCO Offices have been discontinued effective from November 2017 Intermediate(IPC) Examination.

In addition to above, it may be noted that for accessing the result at the above mentioned website the student shall have to enter his registration no. or PIN no. along with his roll number.

Further, facilities have been made for students of Final Examination, Foundation Examination and Common Proficiency Test (CPT)

desirous of knowing their results with marks on SMS. The service will be available through India Times.

For getting results through SMS students should type:

CAFNLOLD (space) XXXXXX (Where XXXXXX is the six digit Final examination roll number of the candidate), **e.g. CAFNLOLD 000128**

Final Examination (New Course)

CAFNLNEW (space)XXXXXX (Where XXXXXX is the six digit Final Examination roll number of the candidate)
, **e.g. CAFNLNEW 000128**

For Foundation Examination result the following :-

CAFND (Space)XXXXXX (where XXXXXX is the six digit Foundation Examination roll number of the candidate), **e.g. CAFND 000171**

For Common Proficiency Test (CPT) result the following:-

CACPT(Space)XXXXXX (where XXXXXX is the six digit Common Proficiency Test roll number of the candidate) , **e.g. CACPT 000171**
