- E. The next agenda of the meeting was to read and approve the minutes of the MC meetings held on 28th July, 2020: CA Abhishek Dhamne, Chairman requested secretary, CA Kashinath Pathare to circulate the draft minutes so that after finalisation it can be uploaded on our puneicai website. He further informed that we are online, our meetings notice and minutes are upload on puneicai website after the finalisation. He requested all to please go through the minutes at their end later on and accordingly we will finalised on email.
- F. The next agenda of meeting was to discuss and plan the forthcoming programme: CA AbhisheK Dhamne, Chairman, Pune ICAI already informed few of the programme, he requested if any one has any suggestions can inform so that accordingly we can noted down and proceed further. CA Sameer Ladda, Vice Chairman updated about the upcoming WICASA programme for the students. Tax Audit jointly with WIRC and Nagpur branch will be scheduled on 12th and 13th September, 2020. He further informed that as per the new unlock guideline received from HO, we are allow to carry out the physical programme up to 100 members. He requested CA C V Chitale for his guidance on it. CA C V Chitale informed that you may send the elaborated proposal to Central Council and CPE committee about the feedback of physical programme along with precautions took during the programme and the responses from students and members so accordingly the standard guideline can be made across all ICAI branches. Also we need to check the guideline from Governments for the physical programme or gathering. Further he suggested instead of having more programme in a rows, we can keep one programme for student and one for members, depending on the response and feedback we can make the special report to Council and CPE committee to give the suggestions/approval for organising more events with more participants.
