- E. The next agenda of the meeting was to discuss on the proposal received from Landlord of Phadke Sankul Premises for renewal of rent agreements: CA Abhishek Dhamne, Chairman informed in details about the renewal of rent agreements of Phadke Sankul. He mentioned that the physical activity at Phadke Sankul Premises are less, Coaching Classes, GMCS & OP we are conducting online. The proposal is due for renewal of next 5 years. He further informed that if all agreed we can continue the premises two more months without the agreement (till 31st March, 2021) and base on the revised guideline from HO for GMCS & OP we will take the call and make the new agreement w.e.f April, 2021. Similar call we can take for Prestige Point. CA Abhishek Zaware mentioned that we should make surplus from the Coaching Classes activities. CA Abhishek Dhamne informed that we will make the note of same and will recast the budget while entering in the renewal of rent agreement.
