## A. Following members were present physically for the meeting:

- C. The meeting was originally planned to be held physically with due care and safety precautions. Similarly nominations were invited by the Chairman for the post of Treasurer. There being no person willing to accept the post of Treasurer, the same was unanimously decided to keep it vacant.

The Ex-officio members were asked their opinion as well as guidance about there being no one willing to accept the post of office bearer. CCM asked the past chairmen of the branch to accept the posts since such acceptance is very much within the guidelines. CA Kashinath Pathare accepted to be the Chairman of the said committee. He assured the members that he shall be deciding allocation of other committees in next few days.

There being no other items to discuss, Meeting was concluded with thanks to the Chair.
