- 1. Conducting Exams:** Pune ICAI stand firmly with the directions and decision of ICAI, H.O for conducting the CA Exam during the COVID-19 pandemic situation and it was strongly backed by Pune ICAI managing committee members –Task Force and staff.

2. **IVRS:** Started the effective way of communication with vendors, members & students by using the IVRS System via mobile from any locations instead of using the traditional landline phone during the difficult time of COVID-19 lockdown.

4. **Mobile App:** Synchronised the website with Mobile App for easy access.

10. **Beautification of the Premises:** Done the repairing of wear and tear parts of premises along with plantation and other beautification of premises to look more attractive & useful.
11. **Additional Space at University of Pune at very nominal rent:** To expand the wings of Pune ICAI tied up with Pune University for additional space for ICAI Classes and other activities.
