THE RISE OF RUPEE AS A GLOBAL CURRENCY

For understanding The Rise of Indian Rupee As Global Currency we have to first understand what is global trade and why it is important for the rupee to be the global currency:

What is Global Trade?

Global trade is the exchange of goods or services between countries and is made up of the total imports and exports of each participating nation.

Each nation in the world is made up of assets and natural resources that they can consume or trade to other nations.

Countries with an absolute advantage on a good or service are the best at producing that good or service and are most likely to export these to other nations.

Top Trade Sectors:

1. Electrical Machinery – Including Computers (14.8%)
2. Mineral Fuels – (14.4%)
3. Nuclear Reactors – (8.9%)
4. Vehicles – (8.9%)
5. Scientific and Precision Instruments – (3.5%)
6. Plastics – (3.4%)

7. Iron and Steel – (2.7%)
8. Organic Chemicals – (2.6%)
9. Pharmaceutical Products – (2.6%)
10. Precious Stones – (1.9%)

Other significant trade areas include service/labor and intellectual property.

How the World got tricked into using US Dollar as Global currency?

The U.S dollar was officially crowned the world's reserve currency and was backed by the world's largest gold reserves thanks to the Bretton Woods Agreement. Instead of gold reserves, other countries accumulated reserves of U.S. dollars. Needing a place to store their dollars, countries began buying U.S. Treasury securities, which they considered to be a safe store of money.

Bretton Woods Agreement: US and its allies came up with an agreement after World War II, which replaced gold with the dollar so all national currencies were valued in relation to the US Dollar, that's how Dollar became so important.

The Oil boom lead to a Dollar boom:

After the World War II, the oil boom lead to a Dollar boom. Dollar became a World's

dominant Reserve Currency, so it only made sense for oil trade to be settled using American Dollars. Oil transactions were made using American Dollars this came to be known as Petro dollar system. Investors stick to it because dollar because it gives them a sense of stability. But on the Government side though the thinking is changing. Many Government are realizing the pitfalls of being overly dependent on the US Dollar.

India's currency rupee can be made as International currency in 2 ways:

- By making rupee as a stable currency to enable International trade or to keep it as asset.
- By exporting more to other countries, so that other countries use these two modes of internationalization are not mutually exclusive. In a one liner statement, for a currency of trade, it needs to be a currency in which assets are held & vice versa.

Steps Taken by the Indian Government:

- The Indian government has taken several steps to improve the stability of the Indian Rupee. One of the significant steps taken by the government is the implementation of inflation targeting. The Reserve Bank of India (RBI) has set a target inflation rate of 4% with a band of +/- 2%. The implementation of inflation targeting has helped to stabilize the INR by keeping the inflation rate under control.
- Another step taken by the Indian government to improve economic stability is the promotion of economic growth through structural reforms. The government has implemented several structural reforms like the Goods and Services Tax (GST) and the Insolvency and Bankruptcy Code (IBC) to boost economic growth. These reforms have led to an increase in foreign investments, which has helped to stabilize the INR.

The demand for the rupee is rising as a result of the booming commerce and investment

in India's economy. With global corporations opening up facilities in India to tap into the nation's sizable and expanding market, the nation is evolving into a more alluring

location for foreign investment.

What are the risks?

- The economy and political stability of India are linked to the value of the rupee, and both factors are susceptible to changes brought on by things like elections, economic slowdowns, and geopolitical tensions.
- If there is an abrupt surge in demand, the rupee may become more volatile. The rupee's value would vary more, which would make it exceedingly difficult for enterprises and investors to plan for future trade and business operations in India.
- The possibility that the dollar and pound might compete with the rupee as it becomes more active globally is another. This might result in the rupee's

depreciation, which would raise the cost of products and services from India on global markets.

- Additionally, if the rupee gains too much traction as a reserve currency, it could result in significant capital inflows and currency appreciation, which would lower exports' competitiveness.

About 30-35 countries, including those from Asia, Scandinavia and Africa, have expressed interest in better understanding the proposed rupee trade.



PANDHARPUR WARI

Pandharpur Wari, also known as the Pandharpur Yatra or Vari, is one of the most prominent and ancient religious processions in Maharashtra, India. It is a centuries-old tradition that brings together millions of devotees who undertake a pilgrimage to the town of Pandharpur, located in the Solapur district of Maharashtra. The Wari is a celebration of devotion and faith, primarily dedicated to Lord Vitthal, a form of Lord Krishna.

The origins of Pandharpur Wari can be traced back to the 13th century when the great saint and poet, Saint Dnyaneshwar, composed the holy scripture "Dnyaneshwari" in the Marathi language. His writings emphasized the importance of devotion and love for God, and he encouraged people to visit the temple of Lord Vitthal in Pandharpur. Since then, the tradition of the Wari has continued to thrive and has become an integral part of Maharashtra's cultural and religious heritage.

The Wari takes place annually during the Hindu months of Ashadha and Kartik, corresponding to June/July and October/November, respectively. Devotees, known as "Warkaris," embark on a journey on foot, covering a distance of approximately 250 kilometers from various towns and villages to reach Pandharpur. They chant devotional hymns, sing bhajans (devotional songs), and carry palanquins with the images of Lord Vitthal and his divine consort, Rukmini.

The Warkaris come from all walks of life, irrespective of caste, creed, or gender, symbolizing the unity and inclusivity of the event. The pilgrimage provides an opportunity for spiritual growth, self-reflection, and the expression of devotion. It is believed that by participating in the Wari and seeking the blessings of Lord Vitthal, one can attain liberation from the cycle of birth and death.

The journey of the Warkaris is arduous but filled with enthusiasm and fervor. They walk long distances, enduring heat, rain, and other challenges, often barefoot. Along the route, local villagers and residents offer them food, water, shelter, and other forms of seva (selfless service). The hospitality and support of the local communities play a crucial role in the successful completion of the Wari.

Upon reaching Pandharpur, the Warkaris gather at the sacred temple of Lord Vitthal and Rukmini. The devotees immerse themselves in the divine atmosphere, participate in religious rituals, and offer their prayers and obeisance to the deities. The temple premises and the town of Pandharpur buzz with devotion, with cultural programs, spiritual discourses, and religious ceremonies taking place throughout the period.

The significance of Pandharpur Wari extends beyond religious devotion. It serves as a platform for social and cultural integration, as people from different backgrounds come together to celebrate their common faith. The Wari also promotes values such as selflessness, humility, and compassion, as devotees demonstrate acts of service and unity throughout the journey.

Discussion Topic 1: Basic Flow Chart for Preparation of ITR:

The importance forms of records and documentation were emphasized throughout the seminar by CA Parikshit Aurangabadkar. Therefore, Sir also defined sources of information of the Assessee. According to him, the person prepare the ITR must tell Assessee to submit the records and study their business model which specially involves the Nature of Business Activity, Nature of Product that they are either in Manufacturing or in Trading and their Tax and Accounting Model. Alongwith that assessee should submit the KYC details and also his Residential Status. The intermediary should Identify the Income and also Classify the Income as of the Audit or Non Audit Assessee.

Discussion Topic 2: The Types of Non Audit Cases of ITR:

CA Parikshit emphasized on the classification of Non Audited Business ITR and summarizes it as follows :-

- A. Either Assessee is Maintaining the Books of Accounts u/s 44AD or
- B. Not Maintaining the Books of Accounts along with they are Registered under GST or Not

Discussion Topic 3: Key Issues in Non Audit Cases of Business Income

Speaker for this topic highlighted the issue which is described in Few Parts which is mandatory for every Individual:-

1. The Assessee should submit the details of Cash and Bank Summary, Study of Cash Flow
2. The Intermediary should cross verify the Cash Outflow
3. Once the records gets submitted, The Reconciliation occurs in following parts-
 - I. TDS deduction in Part A of Form 26AS
 - II. GSTR-1,GSTR-2A,GSTR-3B
 - III. Cash and Bank Deposits and their contra entries
4. Pickup the unusual entries in Bank Statement

Discussion Topic 4: Discussion on Common Mistakes in Preparation of ITR

1. Reconciliation of Purchases and Sales are ignored
2. Cash Outflow is ignored
3. Actual Personal Expenses are ignored
4. Deduction under 80 Series Investments are not considered
5. Any Error in Excel Formulas or Calculations

Conclusion –

Students understood the depth of Each and Every Issue highlighted. The Speaker there was teacher and session was conducted in that manner and students were able to understand about various information. The teacher has also taken the FAQs as to any remaining or left out question would be cleared. The speaker highlighted importance of gathering Information at an early age.
